I wish to draw your attention to section 31 of the Act which requires every organisation which is sanctioned under the Act provide a copy of the **audited financial statements** within **seven (7) months** of the end of the organisation's financial year. Furthermore, section 31(f), the financial statements may be audited by one of the following:

- (i) a person registered as an auditor under the *Corporations (Ancillary Provisions) Act 2001*; or
- (ii) a member of CPA Australia who is entitled to use the letters CPA or FCPA; or
- (iii) a member of the Institute of Chartered Accountants in Australia who is entitled to use the letters CA or FCA; or
- (iv) a member of the Institute of Public Accountants who is entitled to use the letters MIPA or FIPA.

The recorded financial year end date is **30 June**. Please note your first audited financial statements will be required for the period of **18 April 2018 to 30 June 2018**, are required to be lodged with this office by **31 January 2019** with the completed Annual Return (Form 20).
